The Association of Regional Center Agencies (ARCA) and Lanterman Regional Center, along with San Gabriel/Pomona, Eastern Los Angeles, North Los Angeles County, Harbor, Westside, and South Central Los Angeles Regional Centers, would like to invite you to join them at Lanterman Regional Center for a community roundtable. **This event is meant to inform legislators about the crises the developmental service system** and their constituents face, and the options available in the Special Session (X2). **Don't miss this opportunity to hear directly from the community!**



**The event will be done as a roundtable discussion featuring select community members.** You'll hear first-hand from people with developmental disabilities, their families, service providers, and regional centers. They will share personal stories and data about the challenges that years of underfunding have placed on them.

The regional centers provide intake and eligibility assessments to, and are coordinating services for, over 280,000 individuals and their families, and contract with tens of thousands of local businesses that specialize in serving the needs of people with developmental delays and disabilities.
